Seeding Method:

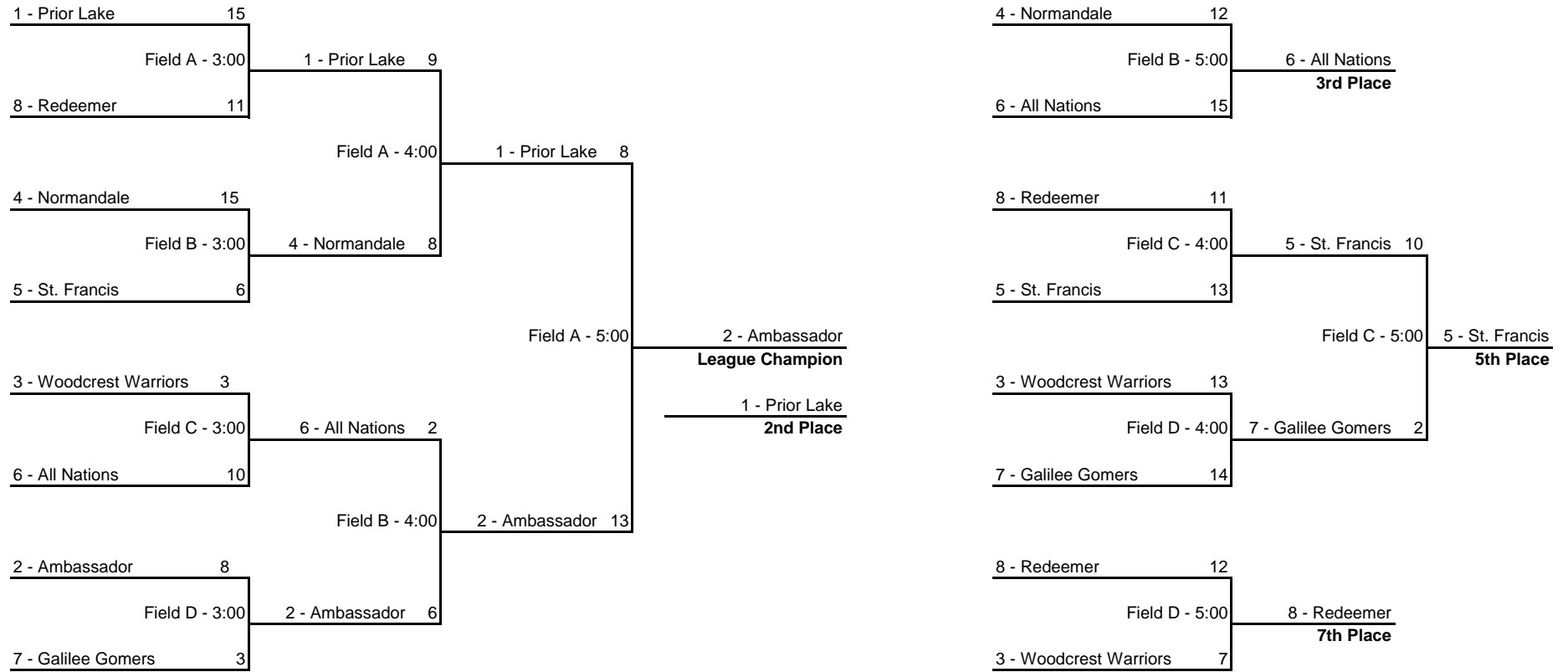
1. Pool winners first, then next best 2 teams for Championship Bracket.
